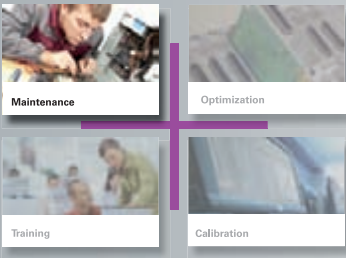
Complete Agreement:

The terms and conditions contained herein constitute the sole and entire agreement between the parties and are the only basis upon which Vision Research, Inc. ("Vision Research") offers to service or repair equipment ("Equipment") of buyer ("Buyer"), unless otherwise agreed to in writing signed by a duly authorized representative of Vision Research. Buyer's terms and conditions shall be of no effect to the extent that they are inconsistent with or in addition to these terms and conditions, and notwithstanding anything to the contrary in Buyer's purchase order, by authorizing the purchase of product and/or services or paying the associated invoice, Buyer accepts all of Vision Research's terms and conditions set forth herein.

Representations and warranties made by any person, including dealers and representatives of Vision Research, which are inconsistent or in conflict with the terms of this warranty, shall not be binding upon Vision Research, unless reduced to writing and approved by an expressly authorized officer of Vision Research.

Warranty:

Vision Research, Inc. ("VRI") warrants that when properly installed and used under normal conditions, each product (other than software/firmware provided to you under license) (the "Hardware") shall be free from defects in material and workmanship for a period of twelve (12) months from the original date of shipment. **NO ADDITIONAL WARRANTIES WHATSOEVER ARE MADE BY VRI.** Claims under this Limited Warranty must be made within the applicable warranty period. If defects in material or workmanship appear during this period, contact Vision Research to obtain a Return Material Authorization number (RMA#) and instruction on how and where to return the hardware. VRI will inspect such returned Hardware promptly to determine the existence of a defect in material or workmanship and the responsibility therefor, if any. If VRI determines that a defect exists and such defect is covered by this Limited Warranty, the Hardware will be repaired or replaced as provided herein. This Limited Warranty covers only defects arising under normal use and do not include cosmetic damage and malfunctions or failure resulting from misuse, abuse, neglect, alteration, problems with electrical power, acts of nature, unusual temperatures or humidity, improper installation, or damage determined by VRI to have been caused by you. Except as expressly provided otherwise in writing by VRI, this Limited Warranty on the Hardware is granted only to you and is non-transferable. **AFTER EXPIRATION OF THE APPLICABLE WARRANTY PERIOD, THE HARDWARE IS PROVIDED "AS IS," WITHOUT ANY WARRANTIES WHATSOEVER. This Limited Warranty gives you specific legal rights, and you may have other rights, which vary among states, provinces, or countries. This Limited Warranty is valid in the U.S., Canada, the European Economic Area and such other countries which VRI has expressly agreed, in writing, to offer this Limited Warranty.

Your sole remedy for a claim under this Limited Warranty is the repair or replacement of the Hardware, at VRI's option. You acknowledge that in making any such repairs to the Hardware, VRI may use parts that are new or reconditioned. VRI reserves the right to substitute functionally equivalent Hardware as a replacement. If VRI is unable to provide a replacement or substitute the Hardware or repair to the Hardware, your sole alternate remedy shall be a refund of payment rendered by you to VRI for the Hardware, exclusive of any costs for shipping and handling.

Taxes and Other Charges:

Should a claim against this or any warranty be filed, VRI will assume responsibility for any parts and labor required to fulfill their obligations. The Buyer shall pay all applicable rates, fees and similar charges imposed by governmental entities, whether federal, state or local.

Inspection and Acceptance:

Any new or serviced/repared Equipment shall be inspected by Vision Research personnel prior to transit to the Buyer and shall be thoroughly inspected upon its receipt by Buyer. Buyer's failure to reject any delivery of Equipment upon receipt shall constitute acceptance of that delivery and shall be deemed a waiver of any other right to reject or revoke acceptance. All claims arising from defective or damaged equipment, except where covered by applicable hardware and service warranties, shall be made within ten (10) days of receipt.
